Subject: RESOLUTION NO. 24-02-09 OF THE TRI-COUNTY METROPOLITAN TRANSPORTATION DISTRICT OF OREGON (TRIMET) AUTHORIZING THE TRANSFER OF APPROPRIATED FUNDS WITHIN THE FY2023-2024 BUDGET

1. Purpose of Item

This Resolution requests that the TriMet Board of Directors (Board) authorize the General Manager or his designee to transfer \$7,458,830 in appropriated funds from TriMet's Safety & Security Division to the Legal Services, Public Affairs and Information Technology Divisions.

3. <u>Reason for Board Action</u>

Oregon Budget Law requires a transfer resolution if expenditures in any appropriation category are higher than shown in the original budget.

- 5. <u>Background</u>

On May 24, 2023, the Board approved Resolution No. 23-05-21, adopting the FY2023-2024 annual budget and appropriating funds. The budget was based on the best available information at the time, because actual revenues and expenses are not known when the budget is developed. Therefore, during the fiscal year, TriMet may need to internally transfer appropriated funds as necessary to match revised expenditure requirements of various Divisions.

Pursuant to ORS 294.463, which regulates the transfer of appropriations within or between funds, such transfers require Board approval. This Resolution will approve the transfer of the total amount of \$7,458,830 in funds previously appropriated to TriMet's Safety & Security Division to the Legal Services, Public Affairs and Information Technology Divisions, as described below:

1) \$2,753,300 must be transferred to the Legal Services Division to expedite the Hollywood Transit Oriented Development (TOD) and Substation Project, advance modifications to One Main Place, and implement programs initiated by the Legal Services Division. From this

amount, TriMet will allocate \$2,133,400 to the Hollywood Project, \$489,900 for the One Main Place modifications, and \$130,000 for mapping and surveying property boundaries.

2) \$459,030 must be transferred to the Public Affairs Division in order to continue TriMet's commitment to increase its presence on the system through additional Field Outreach and Community Relations Representatives. These additional positions will be utilized by Public Affairs to increase the number of TriMet representatives on the system for a limited term.

3) \$4,246,500 must be transferred to the Information Technology Division for the replacement of aging mission-critical radio system equipment originally scheduled for FY2025, but which will be completed in FY2024. TriMet's radio network is essential for operations and safety, and includes substantial infrastructure, multiple towers, redundant connections and over 1700 mobile radios. These funds will be used to replace approximately one-half of the radios that are beyond their 10-year useful life span, and will also replace a number of servers and controllers for the radio system that have outlived their six-year useful life span.

All three budget transfers from the Safety & Security Division appropriation are possible due to the slower than expected filling of positions in both our contracted safety and security services and Transit Police. Although both of these FY2024 Safety & Security Division budget elements have experienced some increase in hiring, the Division currently has sufficient funds to make these budget transfers possible.

These transfers are internal reallocations of budgeted funds and will have no impact on TriMet's approved FY2023-2024 budget.

8. Impact if Not Approved

If the Board chooses not to approve this Resolution, the District will not be able to proceed with the various projects and initiatives that would be funded by these transfers.
