 Clackamas County opened 100 new affordable housing units in Happy Valley on Monday (The Fuller Station)

A safer route for Cleveland High Students

 Changing the Line 70 route means fewer students who live south of Powell will need to cross it on foot. Dropping students off on SE 21st Avenue instead of SE 26th Avenue is safer because of the lower traffic volume on 21st Ave. Additionally, students will spread themselves out on the walk to and from Cleveland High School, minimizing crowding on SE 26th Avenue.

- Most of our riders are paying the adult fares- Did finance consider the Title VI analysis when running the numbers? Yes
- What is happening with fare payments? We need to go out and ask the community again.
- Communicating to the public the benefits of the Hope Pass- The hope pass is not accessible. 85% of payments are paid with Hope

Bylaws Review
